

Will the meeting please come to order? The Subcommittee on Courts and Intellectual Property is in session. Good morning and welcome to a hearing of the Subcommittee on Courts and Intellectual Property on several bills pertaining to the Federal courts. The first bill is H.R. 1443, the Court Arbitration Authorization Act of 1995, which would require all Federal district courts to establish an arbitration program which in the discretion of the court would be either voluntary or mandatory. Last Congress legislation identical to H.R. 1443, which was then H.R. 1102, was reported favorably by the House Judiciary Committee on voice vote and then passed the House on October 12, 1993, under suspension of the rules. Unfortunately, the Senate did not pass H.R. 1102, and instead legislation to extend the 20 arbitration programs currently operating in the Federal courts until 1997 became law. It has been 2 years since the subcommittee last examined this important issue, and this hearing will provide...
